NO-TILL DRILL AGREEMENT

The lessee, _____ agrees to promptly pay a rental rate of (plus tax if applicable):

- **\$13.00 per acre for 7.1 – 49.9 acres, \$12.00 per acre for 50.0 + acres** with full payment within 30 days of completion of work
- **A minimum charge of \$150.00 for less than 7 acres seeded per rental**
- **A \$50.00 fee will be charged** to lessee if seed is left in the seed boxes, and/or additional cleaning of the cultures, tubes, for proper operation
- **Out-of-District fee of \$200.00 will be charged for lessee using the drill out of Buckingham and Cumberland Counties**

The previous user must state the condition of the drill when returned. If upon inspection of the drill, there is wear and tear beyond the normal expected, you have the responsibility of calling the above telephone number or District Cell at 434-315-1401 prior to usage. Abnormal damage must be verified and approval must be given by SWCD before the drill can be used. **Failure to follow** the damage guidelines places the individual liability on the last person that picks up the drill.

The lessee agrees to hold the District harmless for any and all liability associated with the use of the drill by the lessee or his agents, representatives, or employees whether such liability incurred in the field or during transportation to and from the field, including transportation over highways. The lessee also agrees not to hold the District liable for any success or failure of the crop as a result of the use of the drill.

The lessee shall be responsible for:

- 1) Transporting the drill to and from his or her farm or the Peter Francisco SWCD office or SWCD designated location.
- 2) Agreeing to follow all of the drill operating rules that are stated on the drill checklist and rules sheet.
- 3) Furnish a tractor of at least **50 horsepower** and adaptable couplings for use with the drill.

The drill must be picked up and returned to the District Office in Buckingham or Virginia Cooperative Extension Office in Cumberland, unless arrangements have been made by the District or VCE.

This agreement must be signed, dated, and returned before the drill is used.

No-till Drill Rules and Checklist

1. Transport the drill at a speed of 35 mph.
2. **NO fertilizer is allowed to be put in any of the drill boxes, as this corrodes the metal.**
3. **No repairs are to be made to the drill, other than fixing a flat tire, without calling the District office or cell phone first.**
4. **While seeding, do not make sharp turns with the disc in the ground, lift discs before turning.**
5. **The drill is not to be used on newly plowed fields or fields with excessive stumps and/or roots.**
6. **Any damage done to the drill due to improper use can and/or will be charged to the user.**
7. ***Tax Exempt Participants: It is your responsibility to file a Virginia Tax Exempt Form ST-18 with Peter Francisco SWCD office.**
