## **Agricultural Cost-Share Applications for Conservation Practices** **Now Being Accepted for Program Year 2023**

Contact the Peter Francisco Soil and Water Conservation District if you are interested in signing up for the conservation practice program which runs from **July 1, 2022 - June 30, 2023**. The cost-share program provides financial incentives, tax credits, and cost-share to agricultural producers who voluntarily install conservation practices on their farm to improve water quality. Applications and W-9 forms for the cost-share/tax-credit program must be to District staff no later than the Wednesday before the monthly Board meeting to be considered in the monthly round. First round of applications will be reviewed by Board of Directors at their August meeting. All Board meetings are on the third Wednesday of the month, unless otherwise stated.

### **Conservation Practice Opportunities:**

- Varied options are available for **livestock stream exclusion**, with ranging cost-share amounts and an additional buffer acreage incentive payment (amount varies based on buffer width)
- Practices available for **increased rotational grazing**
- Other available practices include:
  - **Conversion of row crop acreage to pasture** (cool or warm season grass establishment)
  - **Conversion of crop/pasture fields to trees** (planting of pine or hardwoods)
  - **Winter Small Grain Cover crops** (harvestable or non-harvestable options)
  - **Nutrient management practices** (PSNT testing, manure injection, etc.)
- **Maintenance funding is available for previous participants with practices that have expired** from their contractual lifespan enrolled in previous livestock exclusion programs and/or animal waste/mortality control programs
